The Legislative segment highlighted the work the American Medical Political Action Committee (AMPAC) is engaged in. ## Spring Leadership Meeting

On April 22, 2015, 29 Alliance members gathered at The Historic Farnsworth House in Gettysburg, PA. The meeting was formally opened at 10:00 AM by President, Anna Kosenko. Caryl Schmitz, our President-Elect, read the Alliance Mission Statement and Prayer. Legislative updates were given by Larry Light, a Senior Legislative Staff member of the PA Medical



Society along with Donna Rovito and Matt Balazik of the Alliance. Marjorie Lamberson of the PA Medical Society Foundation provided an AMES Foundation update which was followed by a presentation by Walt Jones. Mr. Jones discussed the development and current status of the Adams County Foundation. The group ate lunch at The Farnsworth House while members provided County updates. The last event of the day was a Wine Tasting held at Reid's Winery and Cider House across the street from The Farnsworth Hotel.

# Legislation and Politics at AMAA Annual Meeting

**In addition** to fellowship, fun and lots of great food, there was a healthy serving of legislative, political and advocacy information served up at the AMA Alliance Annual Meeting in Chicago June 6-9.

Representing Pennsylvania were PMSA President Anna Kosenko and President-Elect Caryl Schmitz. Also in attendance were Joanne Bergquist and Donna Rovito both PAMPAC Board members and past state Alliance presidents.

Longtime PAC Board member and political guru **Joanne Bergquist** was honored as the runner up for this year's *Belle Chenault Award* for Political Participation. Joanne was nominated by the PAMPAC board for her consistent support of both PAMPAC and AMPAC, as well as for her political acumen and support of medicine-friendly candidates. Joanne and Dr. Eric Bergquist were seated with AMA Alliance President Sarah Sanders and President-Elect Julie Newman when Kim Moser, the first non-physician state PAC chair in the nation, accepted the award.

We are very proud of Joanne for her ongoing support of the political action committees which give physicians and their families a voice at the state and federal levels and her deep understanding of how to be an effective advocate and political volunteer.

A panel discussion followed the AMPAC breakfast and award ceremony, the discussion featured three legislative experts from the AMA: Vice President for Government Affairs Cynthia Brown, Chair of the AMA Council on Legislation Randolph Gould, MD and Senior Legislative Attorney Daniel Blaney-Koen. The three shared "inside" information about AMA's legislative efforts and touched on some of the issues which will be on the agenda in the coming year. The big legislative success story at both the AMA and the AMA Alliance meetings was the repeal of the flawed SGR formula for physician reimbursement from Medicare. H.R. 2 was passed by 392 Members of the U.S. House of Representatives and 92 Members of the U.S. Senate, a significant bipartisan victory in both chambers. Repeal of the SGR means an end to annual scrambles for temporary fixes and the constant disruption to physician practices. Both AMA and AMA Alliance leaders attributed this victory to hundreds of thousands of legislative contacts made by physicians and physician family members throughout the long fight to repeal the SGR.

The important issues on the AMA agenda in coming months are funding for graduate medical education, implementation of ICD-10 coding and repeal of the ACA's Independent Payment Advisory Board (IPAB).
