Mark A. Lopatin, MD, elected for four years as the Second District Trustee. Dr. Lopatin was appointed on February 10, 2016 as the Second District Trustee to fill the vacancy created by the election of John J. Pagan, MD as Vice Speaker in October 2015. Dr. Lopatin's appointment was effective until the House of Delegates annual meeting in October 2016. Dr. Lopatin is eligible for re-election in 2020.

Erick J. Bergquist, MD, PhD, re-elected for four years as the Ninth District Trustee. Dr. Bergquist is not eligible for re-election in 2020.

Donald C. Brown, MD, re-elected for four years as the Tenth District Trustee. Dr. Brown is not eligible for re-election in 2020.

Amelia A. Paré, MD, elected for four years as the Thirteenth District Trustee to succeed John F. Delaney, Jr., MD, PhD. Dr. Paré is eligible for re-election in 2020.
